

DECLARATION OF AGREEMENT AND UNDERSTANDING FORM: **Code of Ethics For Volunteers In Child and Youth Programs**



Believing that God is calling me to serve children or youth in this congregation...

1. My first priority in teaching/supervising/leading children or youth will be to seek the welfare of the children/youth physically, socially, educationally and spiritually. I will also try to understand and respect the child's/youth's cultural background.
2. I will think of myself as a representative or ambassador of Jesus Christ and Lee Street CRC. I will not plan or participate in activities that give a negative representation of Christ, His disciples, or His Church.
3. I will give the parent(s) full information about the program I am teaching/supervising/leading including dates and times and activity plans.
4. If I wish to talk to the child/youth alone, it will be within the sight and sound of other people. I will answer a child's/youth's questions openly and honestly.
5. I will not do anything that will damage a child's or youth's trust. I will try to protect the child/youth from all forms of abuse while he or she is in my care. If a child is distressed, I will try to offer comfort and help. I will encourage them to find the appropriate help for their needs.
6. I have never participated in any sexual molestation of a minor, been criminally convicted of any act involving sexual molestation of a minor, or had a verdict rendered against me in a civil court in relation to any sexual molestation of a minor.
7. I will follow the Discipline Policy of Lee Street CRC and work with children/youth to set some agreed upon guidelines for acceptable behavior within a group. I will seek help from parents and other leaders if needed.
8. I will pray for each child/youth regularly and let them know that I care about them.

I have read and understand the Lee Street CRC Safe Church Policy. I agree to all of its rules of conduct for ministries and will adhere to them. I realize this could result in suspension of my service duties within the church if an allegation of abuse is made against me.
